What is the purpose of the Trust?

The Trust's purpose is to raise additional funds to improve the quality of our buildings and equipment so that students have access to the best possible resources.

What has the Trust provided for students in recent years?

In recent years, the Trust has supported the refurbishment of the school dining hall, the construction of a multi-purpose sports pavilion and the provision of a new minibus. In 2016 to 2017, the Trust funded the new eating area, music opportunities for all Year 7 students and resources for Drama, Film and PE. In 2018, the Trust purchased two sets of iPads and provided funds towards a second outdoor eating area. The Trust also supports disadvantaged students to access opportunities and will be providing money towards the new outdoor classroom.
