The lessons are taught by visiting music teachers, who are self-employed and it is with them who you will have a private contract and be invoiced by.

Students who receive instrumental lessons will be expected to take part in one or more of the school's ensembles. The Music department reserves the right to cancel lessons if this is consistently ignored.

TERMS AND CONDITIONS FOR INSTRUMENTAL LESSONS 2019-20

Your son/daughter has expressed an interest in learning to play an instrument in school. I would be grateful if you could take note of the following points, then sign and return the slip below to the Music department.

The cost of lessons is currently £16 per 30-minute session which is payable directly to the peripatetic teacher with whom you will have a contract, not the school. (Please see point 8 for financial assistance if required.)

Lessons are for 30 minutes on a rotating timetable displayed in the New Music Block and it is essential that your child checks their lesson time each week. It is the **pupil's** responsibility to turn up to the lesson **ON TIME**. Pupils Year 7 – 11 <u>cannot</u> have fixed lesson times.

Regular practice is vital if any progress is to be made and we rely on parents to see that this is done. Regular daily practice is suggested as a minimum.

If your child is absent from school, please inform the teacher directly or the Music department. If there is a clash: school trip, test etc and at least 48 hours' notice is given, the peripatetic teacher may rearrange if possible, but is under <u>no obligation</u> to do so or to make up the lesson at a later date.

Students taking lessons in most instruments will be expected to participate in at least one school ensemble. Lessons can be discontinued if this does not happen consistently.

If your child wishes to discontinue lessons notice must be given in writing to the instrumental teacher and 6 school weeks' notice must be paid.

An annual Music Administration Charge (MAC) of £30 per instrument, which includes singing, is due in the Autumn Term (a pro-rata charge throughout the year.) This is a school payment either payable via Wisepay or a cheque made payable to SWCHS. **Fees are payable immediately upon request in order for lessons to continue.**

Children who are currently in receipt of Free School Meals or who are Looked After may be entitled to financial assistance with music tuition and no Music Admin Charge. Students who are eligible for Pupil Premium Grant support for other reasons, may also be able to access financial assistance with music tuition. In each instance, please discuss this with Mr Blayney (mblayney@swchs.net) before applying for lessons.
